DUTIES OF THE POSITION

Meets with instructor to clarify assignments/criteria for evaluation. Over 50% of the job will involve reading and grading of essays correcting and evaluating grammar, spelling, organization of ideas, clarity, use of sources and course material, and appropriateness of content. May involve some teaching, tutoring, and conducting office hours. Meet deadlines as required.

MINIMUM QUALIFICATIONS

The ability to learn and perform assigned work; work cooperatively with faculty, staff, and other student; and accept responsibility. Completion of specific coursework may be required in order to teach, grade or tutor a course. Admission or registration as a University student. Note: Exceptions to the minimum eligibility qualifications may be granted at the sole discretion of the University.
