**RELEASE OF LIABILITY, PROMISE NOT TO SUE, ASSUMPTION OF RISK AND
AGREEMENT TO PAY CLAIMS; WAIVER**

Activity: All activities of any kind occurring within the Recreation Center and/or under its auspices, including but not limited to the use of the climbing wall, swimming pool, fitness equipment, locker rooms, and other facilities; participation in any personal training, private instruction, group instruction, program, or class; participation in any intramural sports; and otherwise engaging in any supervised or unsupervised activity within the Recreation Center, any activity accessed through the Recreation Center, and/or any activity organized through Sonoma State Campus Recreation.

Activity Date(s) and Time(s): This waiver is valid for the length of your membership regardless of your membership category and whether your membership is active or inactive. If your membership is inactive for 2 or more consecutive terms (a term is considered fall, winter, spring or summer), then you will be required to sign a new waiver. Any person who has a parent/guardian signed waiver on file who becomes an adult must sign a new waiver themselves once they turn 18 years of age.

Activity Location(s): The Recreation Center on the premises of Sonoma State, and wherever else an Activity described above occurs.

In consideration for being allowed to enter the Recreation Center for any purpose and/or to participate in any Activity, on behalf of myself and my next of kin, heirs and representatives, I **release from all liability and promise not to sue** the State of California; the Trustees of The California State University; Sonoma State University and their employees, officers, directors, volunteers and agents (collectively "University") from any and all claims, **including claims of the University's negligence**, resulting in any physical or psychological injury (including paralysis and death), illness, damages, or economic or emotional loss I may suffer because of my entering the Recreation Center, and/or participating in Activities; including travel to, from and during my visit to Recreation Center.

I certify that I have no undisclosed injuries, nor any undisclosed medical, physical, mental, or other condition that may affect my ability to safely participate in the Activity. If I cannot safely participate in the Activity without an accommodation, I will advise the staff in advance of my visit so that a reasonable accommodation, if any, may be found.

I am voluntarily entering the Recreation Center and/or participating in a Campus Recreation activity. I am aware of the risks associated with traveling to/from and participating in this Activity, which include but are not limited to physical or psychological injury, pain, suffering, illness, disfigurement, temporary or permanent disability (including paralysis), economic or emotional loss, and/or death. I understand that these injuries or outcomes may arise from my own or other's actions, inaction, or negligence; conditions

related to travel; or the condition of Recreation Center and/or activity location(s). **Nonetheless, I assume all related risks, both known or unknown to me, of my presence in the Recreation Center and/or participation in Campus Recreation activities, including travel to, from, and during my visit to the Recreation Center.**

I agree to **hold** the University Organization harmless from any and all claims, including attorney's fees, court costs as well as any and all related costs or damage to my personal property that may occur as a result of my **presence in the Recreation Center and/or participation in Campus Recreation activities, including travel to, from, and during my visit to the Recreation Center, as well as any and all participation in any activity.** If the University incur any of these types of expenses, I agree to reimburse the University. If I need medical treatment, I agree to be financially responsible for any costs incurred as a result of such treatment. I am aware and understand that I should carry my own health insurance.

I am 18 years or older. **I understand the legal consequences of signing this document, including (a) releasing the University from all liability, (b) promising not to sue the University, (c) and assuming all risks of my presence in the Recreation Center and/or participation in Campus Recreation activities, including travel to, from, and during my visit to the Recreation Center.**

I understand that this document is written to be as broad and inclusive as legally permitted by the State of California. I agree that if any portion is held invalid or unenforceable, I will continue to be bound by the remaining terms.
